

2012 SUBSIDY APPLICATION INFORMATION

Thank you for applying to register your child in an LDAA-CC program. Operating programs for children with learning disabilities is expensive and the Learning Disabilities Association of Alberta - Calgary Chapter (LDAA-CC) anticipates that you will contribute a portion of the fees. We invite you to apply for fee subsidization and/or talk to us about a payment plan. We accept Visa and MasterCard but are unable to process Debit payments.

Subsidy Info

Our subsidy program is available through the generous support of donors. The amount available for subsidies varies throughout the year depending on donations and amount of subsidies that have been approved previously. The LDAA-CC reserves the right to change the requirements for subsidy approval, and/or set new guidelines for subsidy approval, at any time, without prior notice.

Approval of a subsidy for one program in no way guarantees future approvals. A separate application request must be submitted for each child and for each program requiring a subsidy, although backup documentation only needs to be submitted once in any one year (January to December).

- **A membership, in good standing, with the LDAA-CC is required to be considered for a subsidy. If you are not already a member, please submit your 2012 \$40 membership fee and form.**
- **Memberships are not subsidized.**

To apply, complete a ‘Subsidy Application’ and submit with the backup documents listed on the form.

If your child is eligible for FSCD support, we request that you use that money as your portion of the fees. We can bill FSCD directly within certain guidelines...please contact the LDAA-CC for details.

Any financial information you provide is strictly confidential. We are not able to guarantee the return of the supporting documents attached to the subsidy form as they are not kept in our files, but are destroyed.

Please send copies only. DO NOT provide original documents that you would like returned.
